

2019 Ravens Beach Bash Cornhole Tournament

Contest Official Rules

No Purchase Necessary To Enter or Win.

Purchasing Will Not Increase Your Chances of Winning.

All Federal, State and Local laws and regulations apply.

1) Eligibility: 2019 Ravens Beach Bash Cornhole Tournament (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are 21 years of age or older at the time of entry. Employees, officers and directors of the Baltimore Ravens Limited Partnership ("Club") and each of their respective parents, subsidiaries and affiliated companies, representatives, directors, officers, agents, divisions, dealers, affiliates, distributors, advertising and promotional agencies, employees and assigns, advertising, promotion and administrative agencies; and anyone else connected with the production and distribution of this Contest (collectively "Released Parties") and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related to any of the above named entities are not eligible to participate or win. Void where prohibited or restricted by law, rule or regulation. This Contest is subject to all applicable federal, state, local laws, rules and regulations. Unless you opt-in for future communication, the information you provide will only be used for Contest purposes.

2) Promotion Period: Contest will begin on Friday, May 10, 2019 at 9:00 a.m. Eastern Time ("ET") and end on Thursday, May 30, 2019 at 6:15 p.m. ET (hereafter "Promotion Period").

All registries must be received by 3:00 p.m. ET on Thursday, May 30, 2019 to be eligible. The Contest is limited to the first 16 teams to register. In the event that 16 teams have not pre-registered, a team may register on-site by visiting the Contest registration and check-in area at Ropewalk Restaurant 8203 Coastal Hwy, Ocean City, MD 21842 on Thursday, May 30, 2019 at 2:00 p.m. ET and no later than 3:15 p.m. ET and register your two person team for the Contest. **Limit of one (1) entry per person and per email address throughout the Promotion Period.** Multiple participants are not permitted to share the same email address. Additional entries received from the same person or email address in excess of the stated limitation will be void. All entries become the exclusive property of the Club and will not be acknowledged or returned. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Contest registration is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Club's sole discretion and in accordance with these Official Rules) are void. In the event of a dispute as to the identity of an entrant based on the email address submitted, entry will be awarded to the person named on the applicable entry (regardless of whether that is the name of the authorized account holder of the email address from which said entry form was submitted), provided such individual is eligible according to these Official Rules.

Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, or undelivered entries, or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Contest, including, without limitation, errors which may occur in connection with the administration of the Contest, the processing of entries or the announcement of the prize; or for any injury or damage to participant's or any other person's computer relating to or resulting from participation in this Contest, or for printing, typographical, human or other errors appearing in these Official Rules or other Contest-related materials. Club reserves the right, in its sole discretion, to void any entries of entrants whom Club believes have attempted to tamper with or impair the administration, security, fairness or proper play of this Contest or is in violation of these Official Rules.

4) Winner Selection: On or about 3:00 p.m. ET on May 30, 2019, Club will execute the Contest tournament until one (1) team from the eligible teams wins the Grand Prize. Eligible teams will consist of those teams that successfully registered in accordance with these Official Rules and who are present and checked into the Contest by 2:30 pm ET. Any participant who is late for any reason will be disqualified. The Club will randomly select and pair teams to compete in round one of the Contest. Teams may advance through the bracket of their division by winning their game (in

accordance with the posted cornhole rules) against their opponent with the last team with no losses to be determined the Grand Prize Winner. The Contest tournament will be run by the Club in accordance with the cornhole rules and scoring posted at the location of the tournament. All decisions with regard to gameplay of the tournament shall be made by the Club in its sole discretion.

5) One Grand (1) Prize: One (1) pair of Miller Lite Bar 75 Tickets to a mutually agreed upon Baltimore Ravens 2019 home regular season game. Approximate Retail Value: Two Hundred Dollars. (\$200) All prize details are at Club's sole and absolute discretion.

6) Miscellaneous: No transfer, assignment, cash redemption or substitution of prize (or portion of prize) is permitted, except by Club, which reserves the right to substitute a prize (or applicable portion of prize) with one of comparable or greater value, as determined by Club. Non-compliance with these Official Rules may result in disqualification and, at Club's sole discretion, the awarding of prize to an alternate winner. By participating, entrants agree to be bound by these Official Rules and the decisions of the Club, which are final and binding and agree that: 1.) Released Parties and their designees may use (unless prohibited by law) their name, voice, city/state of residence, photograph and/or likeness for advertising and/or trade and/or for any other purpose in any media or format now or hereafter known, worldwide in perpetuity, without further compensation, permission or notification, and 2.) Released Parties and their designees and assigns shall have no liability and will be held harmless for any liability, loss, injury or damage, including, without limitation, personal injury, death or damage to personal or real property, to entrant or any other person or entity due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of a prize or participation in this Contest. 7) Governing Law: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Participants or the Released Parties in connection with this Contest will be governed by and construed in accordance with the internal laws of the State of Maryland, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.

9.) Taxes: Payments of all federal, state, and local taxes are solely the responsibility of the winners. Winners will be required to sign an IRS Form W-9 with the winner's full social security number or the equivalent. Failure to submit a Form W-9 upon request will result in forfeiture of the prize.
